#### Election of Directors to the Board of RDA (NSW)

Attached please find the Ballot Paper for the election of Directors to the Board of RDA (NSW). Also attached are the profiles of the nominees for the position of Director. As explained later in this letter, there are four vacant Director positions to be filled.

Please number each box in the ballot paper with "1" being placed next to your Centre's first choice as Director, "2" next to the second choice and so on until all boxes are completed.

The completed ballot papers are to be sent to State Office either by email or mail but MUST reach State Office no later than 5pm on Tuesday 14 July 2020. No late votes can be accepted.

This is the first time that Members are able to, or requested to, vote for Directors since the 2012 AGM of RDA (NSW) as, since that year, there has not been a full quota of nominees and therefore, under the Constitution, each nominee was deemed to be elected. It is also important to note that this is also the first time that elections need to be held under the current RDA (NSW) Constitution.

This year would also be a year in which, because of the operation of the terms of the new Constitution of RDA (NSW), there would ordinarily be vacant positions on the Board even though there are more than enough nominees to fill those vacant positions.

Due to the provisions of the RDA (NSW) Constitution, there are a few issues that needed to be addressed in relation to the election for Directors prior to this year's AGM.

Under the terms of the RDA (NSW) Constitution, Directors are elected for a period of two years and are then required to stand down. Then, subject to other provisions of the Constitution relating to the maximum number of continuous terms which can be served, can stand for re-election.

This year, six of the seven Directors are completing their second year since being elected to the Board in 2018. They are therefore required to stand down, with Tracy Lucas, having been elected to the Board last year, continuing until next year's AGM.

Under another provision of the RDA (NSW) Constitution, there must be at least one person, and up to four persons, elected to the Board in any one year.

The purpose of this provision, when coupled with the provision that limits the number of consecutive terms that someone could serve as a Director, is to ensure that there is a rotation of Directors over time.

With Tracy being the only on-going Director and a maximum of four able to be elected, there will be five Directors on the Board for the next twelve months. With the amount of work which Directors are required to perform, this is not a sufficient number. Furthermore, it will give rise to similar problems which will be repeated into the future.

Fortunately, Clause 30.4 of the State Constitution allows Directors to determine a way in which this "problem" can be solved. The Directors made a determination under that Clause that a solution to the problem would be to hold a secret ballot amongst all Directors, using two scrutineers.

The aim of the ballot was to choose three Directors who would be able to have their current term extended by one year, with the other Directors standing down. Those Directors whose term was not extended under this process can stand for re-election as per the Constitution.

The result of the ballot was that Jan Pike, Margaret Norman and Joseph Orland were elected to be the continuing Directors for a further year, while the other Directors can stand for re-election this year as provided for under the Constitution.
