RIDERS RETREAT:

Will be available for all competitors throughout the competition. Full kitchen facilities are available including fridge and freezers, BBQ, Stove, Oven, Microwave and Toaster. It is an expectation that these facilities are kept clean and tidy at all times. Please bring all plates, glasses & cutlery, cooking utensils and equipment.

Coffee Cart facilities will be available.

Horse Accommodation

Bedding will be left in each stable unopened. Do <u>not</u> remove bales from other stables. When bales are opened the plastic wrap is to thrown into the waste bin not the manure bin.

It is suggested that you or your centre bring a wheelbarrow, rake & broom. This will ensure that you get out early as SIEC can only lend out a certain amount of these items.

All bedding must be picked up and placed in bins provided. Riders are responsible to ensure they leave stables clean and tidy. Your bond will be returned only if upon inspection the area is deemed acceptable by a SIEC representative and the Dressage Secretary.

Horses may only be tied to floats connected to cars in the designated "day" parking area.
