

After completing a Degree in Agricultural Economics, I owned and operated a mixed farming				
business at Temora in Southern NSW for 15 years.				
I currently hold the position of Manager Public Health and Professional Products at				
Sumitomo Chemical Australia where I have worked for the last 21 years				
Previous directorships include Riverina Woolgrowers P/L, SEP Meat Processors, Downunda				
Souvenirs and a short term at RDA (NSW).				
I resigned from the RDA Directorship in 2021 because I no longer had confidence in the Boards				
ability to function effectively due to the behaviour of incumbent Directors and considered				
my position untenable. Four other Directors (two with significant exectutive experience) also				
resigned around the same time for similar reasons.				
I am now seeking re-election to the Board to help make positive change which the Association				
so desperately needs. The Board needs to become more professional.				
I beleive we need a Board with a diversity of skills to Govern and guide the Association to grow				
for the betterment of members and the community RDA serves.				
To this end (amongst other actions) we we need to:				
- Remove the absurd "Policy" to restrict Board membership because it				
conflicts with the intent of the constitution which was changed to encourage diversity of expertise				
on the Board at its last review.				
- Finalise and impliment a Strategic Plan in consultation with all members.
