#### PROCESS FOR ELECTION OF DIRECTORS - 2025

## Changes

Under the new Constitution adopted in November 2024 the election process has changed in the following ways:

- 1. The ballot for Directors will be held online and on paper ballots for those physically present at the AGM
- 2. The online & paper ballot will close at the AGM
- 3. Directors will now be elected for three (3) year terms (instead of 2 years)
- 4. There will be nine (9) Directors (instead of 8)

### Special situation for 2025 AGM

At this year's AGM only, there will be an election for 9 new Directors.

This is because under the new Constitution, the length of the terms of Directors have changed from 2 years to 3 years.

Every year after this year, there will be three Directors elected at each AGM.

While the Ballot remains open they can change their vote on the online ballot system.

# 17-May-25 **During the AGM:** Company Secretary will call for final votes to

be cast either online or on the paper Ballot for those at the AGM.

The Company Secretary will then declare the Ballot closed.

The votes will then be tallied and the successfully elected Directors announced.
