# **About RDA (NSW)**

The primary objective of **Riding for the Disabled (NSW)** is to provide people with a disability, the opportunity to ride and drive and enjoy all the activities connected with horse riding. Riding for people with a disability is both therapeutic and recreational and **RDA (NSW)** is in fact one of the few organisations to offer a multidiagnostic service, catering for people with a wide range of disabilities.


The objectives of **RDA** (**NSW**) are to encourage, support and assist Centres to provide riding therapy, sport, recreation, connections, training and safety programs for people with disabilities. **RDA** (**NSW**) offers horse riding, carriage driving, dressage, mounted games and Equine Facilitated

Mental Health and Learning (EFMH&L) and caters for people with physical, intellectual and psychosocial disabilities.

RDA (NSW) currently has 33 Centres spread throughout NSW with 90% of Centres based in regional areas. The Centres cater for 1075 riders annually and are supported by our volunteers. Our community therefore embraces the Centres and the volunteer infrastructure. To adequately support riders with disabilities RDA (NSW) adopts a person-centric focus where all support services are focused on the rider to create a practical, life-changing experience.

## **CASP Report**

CASP (Coaching and Safety Panel) have been busy helping with going through and checking module updates for aXcelerate and also doing Carriage Driving modules updates.

Also checking the extra information sent through from the Centres when there has been a fall from a horse – we understand this may seem like a lot more paperwork but considering past events we felt it was necessary at this time.

We have also been contacted by a few centres with questions regarding problems. We are always ready to be helpful and respond as quickly and helpfully as possible to sort out any queries that may arise. We've also attended to queries and questions from the Board and hope our replies have been helpful.

CASP has monthly zoom meetings to discuss any issues that arise and come to a mutual agreement on these during our meetings.

Coaching and Carriage Driving manuals are being prepared to be updated and printed and will be sent to each centre early 2025.

A number of assessments have been conducted along with workshops, focusing on areas that meet the needs of trainees. The State Workshop at Tall Timbers last year had an attendance of about 80 people and went really well, it also included a Carriage Driving component for the first time in a long time.

There was also a delivery of a couple of Connections (EFMH&L) workshops as part of the Sport Mental Health grant.

An EAP (Employee Assistant Program) was established and conducted some Mental Health Training – a webinar was made available and attended by many coaches and volunteers.

We also conducted centre support audits throughout the state with Assessors and Regional Representatives attending.

We were pleased to support the Mounted Games and Dressage committees coming together to deliver the 2024 RDA State Championships at SIEC, which was also awarded Sport NSW Event of the Year.

The role of CASP is to oversee and encourage the implementation of a quality coaching system which strongly emphasises safety of riders, coaches and volunteers.

Thank you to Westpac Foundation for supporting our Centres and Trainee Coaches for donating 30 reconditioned laptops that were distributed to Centres around the state to enable Trainees to access our online training resources.

## **Finance Officer Report**

It has been my privilege to be the Finance Officer for Riding for the Disabled Association (NSW) for 2024. I was ably supported by our accountant who kept me and the accounts honest and for that assistance I am truly grateful.

It was my pleasure to complete the ACNC Reports for numerous centres, and I am happy to continue for those RDA centres that wish me to continue completing these for them. I am also happy to assist any centre to complete their own ACNC reporting.

There have been some generous donations from the Give Now option on our website which I have endeavoured to disperse to the specified RDA centre or to the one nearest the Donor.

The apparent overall financial loss for 2024 is deceptive due to the dispersal of the Golden Eagle money to the RDA (NSW) Centres. I hope this was of benefit to your centre to provide for those riders benefiting from our riding sessions.

As an explanation of the expenses, we have to take into the account that the Golden Eagle funds that came into last year's finances was dispensed to the Centres within this Annual financial year which then gives us an appearance of increased spending that is out of the ordinary.

The Item that is listed in Operational costs: Grants Dispersed to Centres is relating to the Grants applied for by a Centre and has to be passed through RDA (NSW) as the auspicing body. These are always passed on to the relevant centre.

The legal fees of \$68,452.86 relate mainly to the expenses for legal representation for the Mediation hearing between RDA (NSW), RDA Tamworth and RDA Box Hill which led to the "Heads of Agreement".

Other legal costs incurred are related to the expenses incurred by ongoing challenges by an individual operating a private for-profit business on our RDA (NSW) owned property specifically for riders with a disability. Originally this business did not have adequate Public Liability Insurance coverage that satisfied RDA (NSW) requirements.

As you will note the Rider Registration fees of \$101, 125.38 are what is used traditionally to pay for the Insurance required annually and office expenses.

Please also note that the listing for Box Hill expenses is for the second lease area that is currently vacant and needs to be maintained due to fire hazards etc. It does not refer to the RDA Centre at Box Hill who are responsible for their Centre's maintenance.

### NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 DECEMBER 2024

The financial reports cover RIDING FOR THE DISABLED ASSOCIATION (NSW) as an individual entity. RIDING FOR THE DISABLED ASSOCIATION (NSW) is an Australian public company limited by guarantee, incorporated and domiciled in Australia and is registered as a charity with Australian Accounting Standards and the Australian Charities and Not-for-Profits Commission.

The functional and presentation currency of RIDING FOR THE DISABLED ASSOCIATION (NSW) is Australian dollars.

Comparatives are consistent with prior years, unless otherwise stated.

### 1 Basis of Preparation

The financial statements are special purpose financial statements that have been prepared in accordance with the Australian Accounting Standards and the Australian Charities and Not-for-Profit Corporations Act 2012 and the needs of the members.

The financial statements have been prepared on an accruals basis and are based on historical costs modified, where applicable, by the measurement at fair value of selected non current assets, financial assets and financial liabilities.

The significant accounting policies adopted in the preparation of these financial statements are presented below and are consistent with prior reporting periods unless otherwise stated.

### 2 Summary of Significant Accounting Policies

### **Investment Property**

Although the real property is held primarily for the purposes of the conduct of the RDA (NSW) activities, it is also held to generate rental yields. Properties are carried at fair value, determined by independent valuers.

### **Financial Instruments**

Financial instruments are recognised initially using trade date accounting, i.e. on the date that company becomes party to the contractual provisions of the instrument.

On initial recognition, all financial instruments are measured at fair value plus transaction costs (except for instruments measured at fair value through profit or loss where transaction costs are expensed as incurred).





### NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 DECEMBER 2024

#### Loans and receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. They arise principally through the provision of goods and services to customers but also incorporate other types of contractual monetary assets.

After initial recognition these are measured at amortised cost using the effective interest method, less provision for impairment. Any change in their value is recognised in profit or loss.

The company's trade and most other receivables fall into this category of financial instruments.

In some circumstances, the company renegotiates repayment terms with customers which may lead to changes in the timing of the payments, the company does not necessarily consider the balance to be impaired, however assessment is made on a case-by-case basis.

#### Available-for-sale financial assets

Available-for-sale financial assets are non-derivative financial assets that do not qualify for inclusion in any of the other categories of financial assets or which have been designated in this category. The company's available-for-sale financial assets comprise listed securities.

Available-for-sale financial assets are measured at fair value, with subsequent changes in value recognised in other comprehensive income.

Gains and losses arising from financial instruments classified as available-for-sale are only recognised in profit or loss when they are sold or when the investment is impaired.

In the case of impairment or sale, any gain or loss previously recognised in equity is transferred to the profit or loss.

Subsequent recoveries of amounts previously written off are credited against other expenses in profit or loss.

### Available-for-sale financial assets

A significant or prolonged decline in value of an available-for-sale asset below its cost is objective evidence of impairment, in this case, the cumulative loss that has been recognised in other comprehensive income is reclassified from equity to profit or loss as a reclassification adjustment. Any subsequent increase in the value of the asset is taken directly to other comprehensive income.





### NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 DECEMBER 2024

### **Impairment of Non-Financial Assets**

At the end of each reporting period the company determines whether there is evidence of an impairment indicator for non-financial assets.

Where this indicator exists the recoverable amount of the asset is estimated.

Where assets do not operate independently of other assets, the recoverable amount of the relevant cash-generating unit (CGU) is estimated.

The recoverable amount of an asset or CGU is the higher of the fair value less costs of disposal and the value in use. Value in use is the present value of the future cash flows expected to be derived from an asset or cash-generating unit.

Where the recoverable amount is less than the carrying amount, an impairment loss is recognised in profit or loss.

Reversal indicators are considered in subsequent periods for all assets which have suffered an impairment loss, except for goodwill.

### **Cash and Cash Equivalents**

Cash and cash equivalents comprises cash on hand, demand deposits and short-term investments which are readily convertible to known amounts of cash and which are subject to an insignificant risk of change in value.

### **Revenue and Other Income**

Revenue is recognised when the amount of the revenue can be measured reliably, it is probable that economic benefits associated with the transaction will flow to the company and specific criteria relating to the type of revenue as noted below, has been satisfied.

Revenue is measured at the fair value of the consideration received or receivable and is presented net of returns, discounts and rebates.

### Sale of goods

Revenue from the sale of goods is recognised at the point of delivery as this corresponds to the transfer of significant risks and rewards ownership of the goods and cessation of all involvement in those goods.





### **NOTES TO THE FINANCIAL STATEMENTS** FOR THE YEAR ENDED 31 DECEMBER 2024

#### Rental income

Investment property revenue is recognised on a straight-line basis over the period of the lease term so as to reflect a constant periodic rate of return on the net investment.

#### Interest revenue

Interest revenue is recognised using the effective interest rate method.

### Rendering of services

Revenue in relation to rendering of services is recognised depends on whether the outcome of the services can be measured reliably. If this is the case then the stage of completion of the services is used to determine the appropriate level of revenue to be recognised in the period. If the outcome cannot be reliably measured then revenue is recognised to the extent of expenses recognised that are recoverable.

### Other income

Other income is recognised on an accruals basis when the company is entitled to it.

### **Comparative Amounts**

Comparatives are consistent with prior years, unless otherwise stated.

Where a change in comparatives has also affected the opening retained earnings previously presented in a comparative period, an opening statement of financial position at the earliest date of the comparative period has been presented.







## **Tweed Valley**

#### A year of rebuilding for a future of growth!

The past year at the Tweed Valley Riding for the Disabled has been one of rebuilding. We have overcome several significant hurdles in the past couple of years but have been focused on securing a bright and successful future for our Centre.

Our journey to rebuild our little Centre started when we were awarded a grant to build a new undercover arena. This was unexpected and exciting news for our members who had dedicated countless hours applying for the development approval and grants over the years.

So at the end of 2023, we were happy to report that we broke ground and started construction on our beautiful new arena. It was a lengthy process with extensive earthworks, construction of the roof and obtaining the final sign off from Council. Thankfully between the committee members and a new volunteer who acted as our Project Manager, we were able to complete the project in August 2024 and recommence classes after 7 months due to construction.

We are so proud of our amazing new facility. It has already made a huge difference to our classes, providing relief from the extreme weather conditions that we experience in our area.

Whilst the new arena has given our Centre an exciting buzz, it has been the dedication and hard work of our 20 regular volunteers that has been ensured our ongoing growth and stability. Alongside this, the unwavering loyalty of our 15 local riders has been a cornerstone of our success. Through collaboration, commitment, and community support, we have set the stage for continued impact and progress in the year ahead.

Of course, we would not be able to function without our 17 amazing four-legged friends. Even though we were unable to hold classes in the first part of the year, our volunteers ensured the horses were well taken care of, maintaining a schedule of regular exercise and grooming. We have since worked on desensitising the horses to the new arena environment given some of the horses felt it was a nice big sandpit to roll in.



Our annual charity golf day fundraiser was a smashing success, raising approximately \$6000 for the Centre. We were unsure whether we would be able to go ahead due to heavy downpours of rain leading up to the day, but the weather cleared and a great crew came out to support our Centre. The support from local businesses and the Murwillumbah Golf Club was very generous, making the day our most successful fundraiser for the year.

We have big plans for our little Centre in the coming year. We are hoping to host an official opening of the arena facility, increase our class numbers, train new coaches and pursue further projects to improve our facilities. Thanks to the recent grant from Racing NSW and a surprise generous bequest, we are hoping to make these goals a reality.















### **Manning Great Lakes**

We started the year with volunteer induction and training in February and commenced riding in early March under the watchful eye of Wendy Dunbar who had committed to be a Visiting Coach for Manning Great Lakes (MGL) for Term 1 and possibly Term 2.

In executing our strategy to deepen our Coaching pool, during Terms 1 and 2 we found five volunteers who were keen to become Assistant Coaches. However, two of the Trainees had barely started the course when they had to pause their training due to personal issues. To date neither has returned to the Centre although we expect that one might come back in 2025. Of the three remaining Trainees, one moved to another Centre and one resigned in late October with health issues. Fortunately in early October one of our Designated Riders decided to give Coaching a crack, so at the time of writing this report (November) we now have two Trainees actively completing their modules of the training course. We are hoping that both will be assessed in the New Year boosting our Assistant Coach numbers to three.

Visiting Coach Wendy worked through until the end of Term 2, and fortunately we have been able to continue riding during Terms 3 and 4 with Visiting Coaches from Kendell, Raymond Terrace & Lower Hunter and Central Coast in charge.

As we look forward to 2025 we have been offered Visiting Coaching assistance by Central Coast and our Regional Representative to keep us riding until our coaching shortfall is addressed. Kendell and Raymond Terrace are also likely to come to the party but that has not been locked in yet.

MGL are very grateful for the Coaching assistance we have been given over the last 15 months, and I believe that we have identified a way for other smaller regional/country Centres to continue to provide riding in their communities when they suffer the loss of a Coach.

Our volunteer numbers have remained pretty steady during the year, sitting around the 30 mark, but with a little more churn than is ideal.

Rider numbers remain around 8 to 10, although we expect start pushing that number up next year. While our rider numbers are small the participants are a very happy group, and some are very competent with two of them competing in the August Mounted Games at SIEC. One became the State Champion in their category, the other became the Reserve State Champion in their category.

Our riding Herd of Horses has been refreshed since last year. We now have two horses that have passed the Suitability Checklist and are being used by Participants regularly, and a third horse that is almost through the Suitability Checklist and should come into regular service next year.

Financially we remain solvent and operate with about 12 months of reserves available at all times. Fundraising this year has been slow, but we have applied austerity measures to ensure that our spending remains as low as practicable. Like all Centres we received the Golden Eagle Grant of \$15,000 and used \$9,000 of that to buy a horse, the other \$6,000 is being used to fund more horse shelters and some paddock boundary adjustments.

## Wauchope / Port Macquarie

Where has 2024 gone? It does not seem like one year since our last Christmas party! We have had a very successful year, but very busy because of the weather. Very wet then hot, dry and windy. Not good for our paddocks, more feed had to be purchased. A few days were lost to inclement weather.

We currently have 24 riders, 30 volunteers and 10 horses. Our coaching Staff consists of two Coaches – Sorell Masters who has been with our centre for 14 years and Sue Surace, who is in her 20th year of

volunteering with us – an outstanding achievement! And two Assistant Coaches – Jaci Fisher and Robyn Martin.

We have had to use our vet more than usual this year. A big thanks to State office for our share of the Golden Eagle race money, it made a big difference to our centre.

Coaches and horse trainers have had a very busy time training five new horses, three of these horses have joined our riding group and two more are nearly ready to go. Five of our older horses have been retired or returned to owners. Sadly, we have lost 3 horses, due to age and injury: Ellie 34 years, Abbie 27 years and Lex 25 years.

Our Volunteers have done a terrific job with all the extra work and time given to training and horse feeding them, our horse feeders need a special mention as we had horses at 3 different agistment areas at one time. We are so lucky to have a marvellous RDA family, no job too hard or too small, and all is done with a smile. All the horses are in good condition and working well.

The volunteer maintenance crew have been kept very busy, fencing, cleaning up our new horse paddock in Rosewood. This paddock is on loan to our centre. Maintaining the fences at the Wauchope Showground, installing larger solar panels for our electric fences as well as normal maintenance.

It was with sadness that we accepted the resignation of our long-term coach. Mrs Robyn Coombes, Robyn's health unfortunately let her down. Our treasurer, Mrs Carol Slaughter (1950–2024) who served 6  $\frac{1}{2}$  years also retired due to ill health, Carol passed in late November 2024 and will be dearly missed.

In November a volunteer lunch was held at the Hastings Hotel in Wauchope. Years of service badges were given to the volunteers as well as a presentation of Life Membership certificates and badges. Life membership acknowledgment went to Jack McKinnon, Lindsay Hartmann, Jaci Fisher and Sorell Masters for their contributions.

Our fundraising event this year was a wheelbarrow of goodies, with a second and third prize. This raffle was very successful. All goods in the raffle were generously donated by the community.

The Kevin Waldron Trophy for Most Improved Rider went to Jayden Staniforth, Jayden has been riding with us since he was about 5 years old and finishes Year 12 this year.

The year ended with our annual Christmas party at which the above trophy was presented, a fabulous time was enjoyed by all. So obvious on the day with all the dancing, laughter and of course a visit by the most popular man at this time of the year, Santa!

- Welcomed an influx of new volunteers, most of whom remain.
- Received an invitation and attended Kendall Public School Presentation Day, where 7 of our riders attend school.

#### **Volunteers**

Currently we have 42 volunteers on the books which includes 12 who are feeders only and don't participate on riding days. Our riding days are Tuesday and Wednesday with 3 classes each day.

We have 4 horses who live on site. Our volunteers are very proud of what they are able to achieve with our riders.







### **Raymond Terrace & Lower Hunter**

This year has been eventful as we welcomed a new committee and transitioned from the previous leadership, focusing on progress and continuity.

Our Centre continues to run four programs, supported by a dedicated team of 70 volunteers:

- Monday: 10 riders supported by 24 volunteers.
- Tuesday: 16 riders supported by 27 volunteers.
- Saturday (fortnightly): 6 riders supported by 10 volunteers.
- Stroud Carriage Driving (fortnightly): 7 drivers supported by 9 volunteers.

#### **Achievements and Milestones**

We extend our gratitude to Carol Brown for her remarkable 30 years of coaching and wish her a wonderful retirement. This year, three Trainee Assistant Coaches earned their certificates, and we look forward to their transition to full coaching roles. Several coaches also achieved their Mental Health First Aid certification, enhancing the Centre's support capabilities, and many attended the State Workshop to refine their skills. We were proud to win equal first place in the State photo competition with our entry, "Supa Centre Stage."

#### **Program Updates and Plans**

While our programs have reduced in recent years, we remain committed to expanding them. In collaboration with Manning Great Lakes RDA, we helped maintain their operations, demonstrating the strong community among Centres.

From 1 to 21 September, we held Mounted Games during program days, delighting riders. We aim to reintroduce the Regional Mounted Games next year. At Stroud Carriage Driving, we piloted a competition based on Ridden Mounted Games, adapted for carriage driving. This initiative was highly successful, and we hope to expand it to a state-level event to replace the discontinued RDA (NSW) Driving Championships.

#### Infrastructure and Grants

Significant progress was made this year:

- Facilities upgrades: A grant enabled us to improve stormwater systems, repair gutters and downpipes.
- Technology: Two laptops were received from RDA (NSW) for trainee coaches. We have also applied for funding to replace ageing PCs with two additional laptops.
- Wash Bay: Construction has begun and is set for completion early next year.

While our grant application for parking and lighting enhancements was unsuccessful, we remain hopeful for future opportunities.

#### Administration

Administrative improvements included creating a central database for data integrity, setting up cloud storage for secure document access, implementing mailing lists with an unsubscribe option, and streamlining filing systems for better organisation. Additionally, we introduced professional email addresses for each role at our Centre.

#### Volunteer Recognition and Fundraising

Two dedicated volunteers received Volunteer of the Year awards, hand-delivered by the President. Both were thrilled with the recognition. Fundraising efforts included Bunnings BBQs, a Ride-A-Thon with a colour theme, and Melbourne Cup events. While we faced some challenges in fundraising this year, these events were well-received and supported our operations.

#### **Looking Ahead**

We are optimistic about expanding our programs in the coming year, with the continued support of our skilled coaches, volunteers, and community. Thank you to everyone who contributed to this year's success.





## Ryde

#### **Riding**

2024 has been a busy and successful year. Through passion, hard work, and teamwork, we have provided over 1,900 rides this year. This is a 50% increase from 2022. To achieve this we have expanded our volunteer base, enlarged and improved our herd, graduated more Coaches, broadened our community engagement and upgraded our facilities. We provide lessons four mornings a week, for individuals and school groups.

#### **Special Events**

What better birthday to celebrate than the Horses' Birthday? On Sunday, 28th July 2024, over 300 locals enjoyed a jumping castle and face painting. The star attraction was our horses who delivered over 100 pony rides! In November 2024, our first Ryde Centre Mounted Games in Marsfield were held, with riders of all abilities participating.



#### **Volunteering**

Attracting and retaining volunteers is a challenge familiar to all charities. We have a dedicated core of volunteers, with new members joining each year. To deliver safe and enjoyable classes we focus on training and welcoming our new volunteers to the Ryde family.

#### **Community Support**

Ryde Centre is run by volunteers, with no paid coaches or admin staff. This keeps us busy, but it also attracts and inspires ever growing support from the local community. We are fortunate to have backing from local Rotary Clubs, sport clubs, and other local businesses who support our riders directly or indirectly. We even received a donation of Mobi mats from the Sutherland Shire's Surf Life Savers! This year, we were fortunate to receive two generous grants from Bendigo Bank, enabling us to have another horse and to build a small outdoor arena over summer. The Hogan Foundation continues to support us and the Goodman Foundation has funded one of our horses for two years.

The City of Ryde has been a great landlord, building a much-needed new car park and providing practical grants to assist our classes. Corporate working bees enable us to address the backlog of maintenance

jobs. Many of our volunteers not only provide their time but also donate. Without all this support, we would not exist.

#### Horses

With the retirement of 27 year old Rolly at the end of this year, the average age of our herd is now quite young. Our seven resident RDA horses are strong, healthy and energetic. We are so fortunate to have such adorable four legged partners who are willing to carry their precious cargo and who connect in a magical way with our riders.

#### **New Developments**

In 2024, we finally put a handsome roof over our grooming yards. Over summer, we are landscaping to create a small outdoor multipurpose precinct where people in wheelchairs can safely pat, groom, chat, and connect with our horses.



#### **Governance and Strategic Direction**

The future of RDA (NSW) Ryde is bright. We greatly admire the work of past and present volunteers without whom we would not exist. While we face challenges in an increasingly complex workplace, at Ryde, we remain optimistic that we can continue to blossom for the sake of our riders, their families, and others living with a disability.



### **Box Hill "Tall Timbers"**

2024 was a great year enabling 139 Participants and their families to benefit from the equine programs at Box Hill "Tall Timbers".

We continued to diversify our programs in response to participant needs and offer the programs to individuals and school groups and adult day programs.

We attended and held many events throughout the year to helps spread the word about what we do. Box Hill "Tall Timbers" representatives attended the Premier's Volunteer Reception. Fran, Karen and Cuddles celebrated Australia Day 2024 along with the local Lions Clubs and the Community at Bella Vista Farm. Beyond Bank held a Double your Donation Campaign to benefit Tall Timbers. Golf Day is held in March at Lynwood Country Club.

Box Hill "Tall Timbers" received funds for 2024/25 equine programs through Castle Hill RSL ClubGRANTs. We received a grant from Coca Cola in the Community. CommBank Staff Foundation Community Grants will allow Box Hill "Tall Timbers" to mentor trainee Coaches. Community Enterprise Foundation of Bendigo Bank Galston assists with the cost of the Tots and Tiny Tackers Programs. We received a Small Equipment grant to purchase safety equipment for the volunteers.

The Profield Foundation continued to support of the Centre. BNI Sydney North West and Penrith included Box Hill "Tall Timbers" in their Charity Collective Golf Day. We participated in the Orange Blossom Parade through Rouse Hill Town Centre, attended Community Connect as well a market at Castle Hill Art Society.

Congratulations to Fran and Lauren, nominated for Volunteer Recognition Awards in the NSW Volunteer of the Year Awards through the Centre for Volunteering. Fran Prudames was presented with a Life Membership of Box Hill "Tall Timbers" and Kim Kozis was awarded a 25 Year Service Award.

#### **Centre developments**

No major new developments at Richmond this year but with forethought and planning got the ramp supports repaired ready for 2025, the horse standing area floors refreshed and a plan is in place to refresh the volunteer outdoor seating area in early 2025, long term plan is to cover the area between ramp and arena and grants to be applied for to carry out this work.

#### **Riders**

- Number of riders currently was 22.
- Rider goals were all on track with many now achieving using reins and free riding.
- Katie Leech continues to surprise us every week by attending even after life threatening medical issues; Adrian abilities continue to develop and his enthusiasm is contagious; Gretta's drive and determination to overcome her Cerebral Palsy to allow her to ride is wonderful to see. All riders were amazing at all levels!
- We were not able to attend SIEC again this year due to the Uni quarantine regulations, we may be able to in 2025 if we get two more horses to cover.

#### Horse stories

We currently have 4 horses. Burger continues to be the head of herd and Gibson, the film star is still everyone's favourite; Monty gets cuddles because he has a forelock and mane like a punk rocker and Big Mac is just Big grumpy Mac. We may have two new horses at beginning of 2025.

#### Coaching

The current team consists of three Coaches – Wendy, Ian, Mal and one Assistant Coach - Bruce, one Training Assistant Coach – Laura. Sadly Clare had to step down due to health issues.

#### **Community Events and Fundraising**

- A big response from our volunteers to do the gates at the Hawkesbury Show and annual event raised nearly \$3000 and everyone had fun at the show doing it.
- Ian did two presentations at the Richmond Rotary where the centre received a certificate of thanks for helping Rotary with their work.
- Sky Sport TV asked Ian to assist with making TV programs at the centre for Sky TV. The Shed Company and Dulux Paints are all supporters of Richmond. The riders and volunteers did a TV interview for 7 NEWS which was shown on TV which they were all excited about.

#### **Volunteers**

Volunteer numbers were stable throughout the year around 6-8 each session attended. Most volunteers describe their volunteering as a warm feeling of satisfaction being able to help others.



## Wollondilly

We were to start back on the 30th January with a Working Bee which unfortunately was cancelled due to bad weather.

On Australia Day Rosie our Coach received an award – Wollondilly Citizen of the Year for her work with RDA and Pony Club.

In February the wonderful apprentices from Simec Mine at Tahmoor came and started on more jobs from our "bucket list". They made a wash bay near the horse stalls, erected a safety fence and made a footpath to improve access from the car park to the building.

In February the local RFS did a Training Exercise on our grounds and also on another day did some pile burning on our grounds.

In early March we had a Training Day. We also held a barbecue to thank the apprentices and staff from Simec mines, the army personnel from Holsworthy and a representative from the Department of Community Justice to thank them for their continued support of our Centre. Matilda and Tracy, our two individual riders gave the visitors a demonstration of what they do at RDA.

In March our Treasurer Evelyn, Rosie and Marie received a certificate at a Morning Tea at the office of our local member Judith Hannan MP.

Also in March we finished spending the last of our Black Summer Bushfire Grant with slashing done on the Denmead Street side of our block.

Our first RDA riding day for 2024 was Tuesday 19th March with everyone happy to be back and looking forward to the year. Our individual riders, riders from Aspect and Beverley Park schools were also happy to be back. Our wonderful horses and ponies, Hummer, Sarge, Bella, Bonnie, Willow and Chris came back ready to start the year.

In May a local organisation OSCA contacted us regarding a donation to our Centre. They donated \$500 to be used for Equine Therapy which enabled the horses to enjoy the benefits of a lovely, relaxing massage.

## Young

Christopher has been attending RDA for many years with the pinnacle Group, but as his day at the centre changed, his Monday carer brings him on riding days.

Finally, there is Lucy, from Cootamundra who has ridden for many years with the school and now comes with her carer. She is always very cheerful, loves her ride and is always helpful. From Junee, comes Emma with her carer. Previously Emma came as a volunteer at Cootamundra some years back and now is a keen rider with a lot of horse experience. Also, there is an entire family attending as participants at RDA including mum, Amber, due to her recently acquired disability.



We held special days with our riders such as celebrating Paralympics with our riders competing for medals. Also Remembrance Day was with our riders respectfully standing still on horseback for one minute at 11.00 am on the 11th November

#### **Volunteers**

Towards the end of 2024 year, we gained a few new volunteers who are very keen and eager. Some are volunteers with horse knowledge and experience which has been a most welcome addition.

One volunteer, Robyn has cleaned out our hayshed in preparation of the delivery of the new season's bales of Lucerne. I have never seen it so clean! Plus, the forecourt area has been cleared to make it easier for our participants and horses with no loose large stones and rocks.

Trees growing over the arena area were trimmed to avoid rubbing. We have made a start on our Activities Paddock with 1-10 activities, plus a slippery dip used for ten pin bowls.

#### Riders/Rides

This year we had 24 riders, some began learning to ride offlead which is a big step for them. Melbourne Cup Day was again a huge success. Kids got to wear real jockey silks and compete in races on the day to win ribbons and a cup!! We are lucky enough to have great trails at our Centre, so Trail riding was embraced enthusiastically.

#### **Horse Stories**

We have 17 horses this year with Rocky our newcomer. We celebrated horses birthday with our caretaker making individual cakes for all the horses, who absolutely loved them.

Patches did need the vet for a mild case of colic but she was all patched up and soon back to her happy self again. Polly forgot gates have to be opened to get out of the paddock, and ended up stuck half way through one, but luckily help was on hand and she was freed upharmed.

It has been three years since two horses were stolen and they are still missed dearly.

#### Coaching

We had quite a year with coaching continuing to run three days, but with fewer classes, due to school staffing.

Our Coaches Julie Karen Denise and in training, Lisa and Crystal do an amazing job.

Highlights were Melbourne Cup. The Children were jockeys for the day, with much fun and 2024 Horses birthday, the children gave the horses carrot cakes. Both horses and children loved it.

Biggest thrill for our centre was our Wednesdays participating in the Musical ride for 2024, and being announced the Winners!!!

Everyone put in a lot of hard work and we were very surprised due to the small size of our centre.

#### **Community Events and Fundraising**

Again our fundraising is so important to the running of our centre.

Golf Day, Pie Drive, Biggest Lap, Showgate Movie night and Raffle.

Community in Griffith is very generous and sponsorships and donations from businesses and individuals are appreciated.
















## Gunnedah

The fact that this centre managed to survive is in its self a significant achievement. Numbers of riders have been declining since the Covid epidemic and this is a significant strain on the efforts of our ageing volunteer group. As one of our senior coaches stated it is a lot of hard work for only 9 riders. It is rather underwhelming when the parents of needy suitable children do not follow the requirements for enrolling their children who would benefit from our services. For some reason they baulk at getting the appropriate doctor's certificate or the payments necessary for acceptance to benefit from the interaction with horses and willing helpers. The general community really appreciate our work it is obvious that some who would benefit do not. It may sound a bit gloomy and at times it feels beating your head against a brick wall.

Currently we are using three riding horses and our whips are providing their own horses for carriage work. Gunnedah has two very good carriages which are used for people with severe disabilities and those deemed to be too heavy for the riding horses. The centre also has two very suitable horses in reserve but no actual carriage horses.

At the time of writing we have approximately 18 regular clients but this number can fluctuate wildly depending on the day. We have only 2 adult clients who ride in the carriage.

This centre is financially secure at the moment especially with the release of the \$15,000 from the winnings of the Golden Eagle horse race but that notwithstanding the Gunnedah community seems to consider RDA to be a great service and have been extremely generous over the last 12 months.

This centre is well equipped with fully trained and competent Coaches and Whips. Currently we have 2 fully qualified Coaches, 2 Assistant Coaches, a Senior Whip as well as an Assistant Whip. It is not that we are short of coaching talent we are having difficulty attracting people who would benefit from our services. This year we have been particularly fortunate to have youthful volunteers from the Gunnedah High School to help on riding day. These young people have provided sterling service on every riding day, their legs are much fitter than the rest of us.

As previously mentioned the lack of the appropriate people needing our services is the main concern of this centre and it is a worrying situation for the committee not to mention our ageing volunteers. (a common problem we are led to believe in all volunteer organisations) It would appear that there is an apparent unwillingness to find time to help or that social pressures have taken over with both parents of disabled children having to work.

At the moment the initiative is trying to drum up business for next year. However, it is fair to say that the centre had a reasonably successful year and we are looking forward to improvements for 2025.

## Narrabri

A great year with 21 volunteers, two coaches, 19 riders, three ground participants. eight amazing horses, with Tony Pony joining us at end of season, which was perfect for the on-ground participants and any not wanting to ride.

The atmosphere of enthusiasm was contagious and great to be around. The organization of willing volunteers and willing coach created far less chaos and a less stressed head coach!!

Along with faithful horse donors – delivering their "babies" and having them in a good frame of mind and good health.

All participants noticeably improved, gained confidence and had obvious enjoyment, although some did not like to let on!! Lexi especially pushed buttons, riding off lead-walk, trot and a short canter. Great excitement!

On the whole our goal of "Safety, Therapy and Enjoyment" was fulfilled.

Very grateful to all participating in committee meetings and the executives fulfilling their rolls, keeping us on track. Jenny Wilkinson completed a full audit this year, thanks to Rose for fulfilling a lot of those needs.

Our status was reinstated to Accredited from Provisional.

I sincerely want to thank each individual - you make it ALL happen - Trish (Head Coach).

## **Tamworth**

The Tamworth Centre is busy seven days a week looking after our nine resident horses. We have daily rosters for feeding and checking horse welfare. Our wonderful volunteers take great care of our horse family. We held riding sessions on Tuesdays and Saturdays whilst our main riding and carriage day remained on a Thursday during school terms in 2024. Our wonderful participants were of a wide range in age and abilities, from primary school to adults, attending from Hillvue Public School, Quirindi Challenge and various independent riders from around the Tamworth district. Riding and horse activities including carriage driving were thoroughly enjoyed by all. Throughout the year we welcomed 41 registered participants.

We were very pleased to host a session with the SES Large Animal Rescue and assisted them in their training. Our Coaches, trainee coaches, volunteers and horses assisted with the horse handling session. Our horses were on their best behaviour and an enjoyable and worthwhile session was had by all.

The Tamworth RDA Centre was afforded the opportunity to install day yards for our horses with the help of a grant from State Office. These yards have greatly assisted the horse welfare volunteers by providing a safer environment to secure, feed, and care for the horses efficiently.

We have had three Trainee Assistant Coaches working through their course throughout the year. They have made excellent progress and are a very valuable addition to the team of volunteers.

We thank them for all their hard work.

The Tamworth Show invited us to participate in the Grand Parade where several of our volunteers walked in the parade wearing our RDA uniform and Sue Wilson, our President, spoke about what we do and the opportunities for volunteering at our Centre and gratefully accepted a cheque for \$2000.

We continue to receive generous community support with donations that greatly assist the running of our centre. This year again we were again asked to participate in the Interschools Horse Extravaganza (ISHE). We acted as volunteers for pencilling for the dressage and assisted with marshalling. All proceeds from the four-day event went to volunteer organisations and for our presence we were generously supported financially. The Longyard Golf Club kindly named us as the beneficiaries of their raffle held in conjunction with the Longyard Cup event, this also provided us with a great way for our volunteers to meet more members of the community whilst also fundraising for our Centre. We had a table at the local Volunteers Day Expo, where we met locals and discussed our work at RDA Tamworth Centre. We met many others who are also doing their part volunteering in this great community.

We have had a happy and productive 2024 and look forward to again assisting our RDA Community by providing therapeutic equine activities and opportunities for our participants with special needs and disabilities in 2025.
